**2018 Mountain Springs Country Fair Vendor Contract**

The Mountain Springs Country Fair herein referred to as MSCF does hereby agree to let:

Herein after referred to as vendor, rent frontage in the display area at the 2018 MSCF, June 14—16, 2018. The MSCF agrees to reserve space until 3:00pm June 14, 2018 provided that vendor completes, signs, and returns this application to MSCF with full payment and ALL documentation required by June 1, 2018. First come first serve basis. The MSCF has the right to make all decisions on the acceptance of all vendors.

**Vendor agrees to:**

1. Indemnify and hold harmless MSCF and Mountain Springs Arena from and against all liability and damages occurring in the course of the vendors operations under this agreement.
2. Provide to MSCF a certificate of insurance to cover vendors operation during the MSCF. The insurance will include coverage for MSCF and MSA.
3. Provide to MSCF a PA sales tax number
4. Provide pictures of display, showing all aspects of the display, and samples of all handouts used if requested by MSCF.
5. MSCF having sole right to say a display or parts of a display are offensive. These offensive displays or parts thereof will be removed from the fairgrounds or put behind screens, provided by the vendor with signage stating that there is offensive material behind screen.
6. MSCF having sole right to say handouts are offensive. These offensive handouts will not be allowed on the fairgrounds.
7. Have full display erected by 3:30pm June 14, 2018, and removed by noon June 17, 2018.
8. Keep full display up and open ALL hours of the fair's operation and will not remove it before 10:00pm June 16, 2018.
9. Remove ALL vehicles from the fairgrounds at least 1 hour before opening of the fair to the public.

10. If MSCF is prevented from holding the fair or any element thereof by reason of cause which are beyond its control such as acts of God, forced majority strikes, epidemic, accident, transportation delays, sickness, government action, or any other cause of a like nature. MSCF shall not be in breach hereof and shall have no obligation to the vendor except to refund the vendors display fee.

**MSCF also agrees to:**

1. Have security on the fairgrounds from 3:30pm June 14 through 10:00am June 17, 2018.
2. Have EMT on the fairgrounds during hours of operation.
3. Supply each vendor with four (4) vendor passes and (2) two vehicle passes, more vendor passes can be purchased.
